AFFIDAVIT

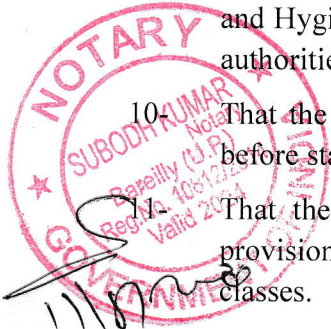
